CIRCULAR ON FEE DEMAND

The Even Semester classes are scheduled to begin on 03 May 2021. Hence, all cadets of M.Tech(MEM) & MBA(ITLM) are instructed to pay their Semester Fees for the forthcoming even semester as per the fee details given in the table below:

Time Schedule for Payment of Fees& Details of Penalty:

a) No Penalty: -If the Semester Fees are paid in full within 15days of the opening day of the Semester (i.e. upto 17 May 2021), there shall be no penalty

b) With late fine of Rs.200/- per day: -The Penalty for late payment of the Semester Fees between the 16th day (i.e.18th May 2021) & the 45th day (i.e.16th June,2021) from the opening day of the Semester shall be @ Rs.200/-per day, even if the Semester fees had been paid in part within the 15 days.

c) Removal of the name from the Rolls of the University and expulsion from Hostel: If any part of the Semester Fees together with the penalty payable remains unpaid even after the 45 days from the opening day of the Semester the names of the defaulters shall be removed from the rolls of the University and they shall be expelled from the Hostel with effect from the 46th day (i.e.17th June 2021).

d) Permission to rejoin the Semester on payment of Semester Fees together with the penalty payable in full plus Readmission Regn. Fees of Rs.10000/-: The defaulting student may be permitted to rejoin the Semester if, between the 46th day(17 Jun 2021 and the 75th day(16 Jul 2021) from the opening day of the Semester, he pays the Semester Fees together with the Penalty payable in full and further pays a re-admission Registration Fee of Rs 10000/-. The student shall be solely responsible for any shortfall of attendance due to this break

e) If the defaulting student fails to avail of even this window of opportunity and does not pay the Semester fees together with the Penalty payable in full along with the re-Admission Registration Fee of Rs.10000/- within 75 days(i.e 16 Jul 2021) from the opening day of the semester, then the student will have to suffer a break in study & rejoin the same semester in the following academic year provided he clears all the pending dues in full & after obtaining the prior permission in writing from the University.
