Sealed quotations are invited towards shifting of Empty Container from IMU Kolkata Campus based on the following Technical Specifications:

The scope of work to be carried out is as under:


1. Loading of container is to be arranged by transporter.
2. Transporter shall quote for transportation charges per consignment including all other incidental charges, detention charges.
3. The transporter shall ensure that container must have a proper lashing/choking/bracing.
4. In case of an accident in transit, or for any other reason, if the container needs to be transhipped on to another vehicle/chassis en-route, the transhipment shall be carried-out by the transporter at his cost and risk. The transporter shall also be liable to pay the compensation/claims arising out of any damage to the container. The contractor shall also be liable for any third party claims and damages.
5. In case of long lead road transportation, events like imposition of restrictions on movement by State Government authorities on a particular route or in certain timings or diversion of routes on temporary basis due to civil works, law and order situation, festivals, etc. shall not form the basis for claiming higher rates.
6. Driver of the vehicle should have valid license for heavy motor vehicle. He should produce the same, if necessary.
7. Transporter shall ensure that only vehicle in very good running condition is deployed for this purpose. Also the valid documents required for the vehicle should be available.

Terms & Conditions:

1. Bidders should quote their rates based on the above specification and scope of the work.
2. The rates quoted should be inclusive of all but excluding taxes, which should be stated separately.
3. The rates quoted should be valid for one month from the last date of submission of quotation.
4. Work should be completed within 15 days of placing order.
5. LD charges would be imposed in case of delay in the work @ 0.5% per week or part of a week subject to a maximum of 10% of the value of the work order.
6. Submission of multiple bids by a single firm will lead to rejection of the bids and IMU-KC may black list such firms from future participation.
7. Last date of submission of quotation is 25.03.2021.
8. The quotation is to be submitted in sealed envelope clearly subscribing "Quotation for Shifting of Empty Container from IMU-KC to INS Eksila, Visakhapatnam".
9. The envelope should be addressed to the Dy. Registrar, Indian Maritime University, P - 19, Taratala Road, Kolkata - 700 088 and deposited in the Tender Box kept at the Dy. Registrar's office (1st floor, Room No. 130) or can be sent by post.
10. The envelopes are to be sealed properly with gum and not by stapler pin.
11. Full payment will be made through Bank Transfer (NEFT) within 15 days after successful delivery of the Container at INS Eksila, Visakhapatnam.
