- Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the Work Order, IMU-KC will be entitled to deduct/recover the Liquidated Damages for the delay @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever. IMU-KC reserves the right to increase or decrease the required quantities as mentioned above.
- The rates quoted should be valid for two months from the last date of submission of quotation. IMU-KC may place further orders during the said period depending on requirements.
- Items should be delivered preferably within 2 (Two) weeks of placing order.
- Submission of multiple bids by a single firm will lead to rejection of the bids and IMU-KC may black list such firms from future participation.
