- 8. Last date of submission of quotation is 20.02.2019.
- 9. Quantity of RFID reader may be increased or decreased based on requirement.
- 10. IMU-KC reserves the right to split the order between different bidders in case of tie.
- 11. The quotation is to be submitted in sealed envelope clearly subscribing "Quotation for RFID Reader (Wireless)".
